Unfinished Business

The sewer engineer would oversee that the manhole is placed correctly and would need to get us a detailed scope of what is needed.

Ms. Black requested the supervisors mark the blacktop outside the doors so the saw being rented August 14 could also be used at the building so the voids under the building could be investigated.

Mr. Campbell made a motion to use Stiffy's Well Service to install a water softener and iron filter, seconded by Mr. Whiting. Roll call vote: Bryan Cummings – yes, Ray Campbell – yes, Joe Whiting – yes.

Ms. Black will look into getting quotes for a new truck. A motion was made by Mr. Campbell to hold a special meeting Wednesday, August 16, 2023 to discuss the trucks further, seconded by Mr. Whiting. Roll call vote: Bryan Cummings – yes, Ray Campbell – yes, Joe Whiting – yes.

Quotes on forks and a quickhitch for the new John Deere tractor was obtained for next year's budget.

The employees were given permission to scrap the old mower frame.

Mr. Cummings will look at a driveway culvert on Angel Road to determine if it needs replaced and if it does, what size will be required.
