The meeting was called to order at 7:00 p.m. by Joseph Whiting, with Ronald Steingrabe in attendance. Donald Bolinger was absent. Guests present were Joyce Boos, Pastor Rob Cypher, Kristen Johnson, John Martin, Steve Yoder, and Joe Plawky. The pledge to the flag was given.

#### Public Comment

The July 9, 2025 meeting minutes were approved by a motion from Mr. Steingrabe, seconded by Mr. Whiting. Roll call vote: Joseph Whiting – yes, Robert Steingrabe – yes, Donald Bolinger – absent.

#### Unfinished Business

Kristen Johnson from the EADS Group explained the updates to the sewer report timeline. She will email the borough to follow up on an updated agreement. The township needs to follow up with Gannett Fleming once a week about revisions. Preliminary design is ongoing to Bethel New Wilmington Road and Cowden Road. Meeting date set for September 4, 2025 to meet with John Whiting to determine if gravity alignment is feasible for Mercer New Wilmington Road. EADS Group hope to have design layout for Bethel New Wilmington Road in September. Kristen suggested contacting the state about an extension of the H2O grant.

Nothing new to report for the Number 8 Road bridge.

School Zone study will be tabled until September's meeting.

Nothing to report on an Emergency Management Coordinator.

There is no update on an ATV Ordinance.

#### New Business

Mr. Steingrabe made a motion to add Jennifer Harvey to the bank signature card, credit card and to be bonded at \$900,00.00, as well as receiving holiday pay. Mr. Whiting seconded the motion. Roll call vote: Joseph Whiting – yes, Robert Steingrabe – yes, Donald Bolinger – absent.

After a brief discussion, the supervisors chose to table the ten-acre sewage exemption discussion until the September meeting.

A Resolution 2025-9 was made to update the wording of the policy. Mr. Steingrabe made a motion and Mr. Whiting seconded. Roll call vote: Joseph Whiting – yes, Robert Steingrabe – yes, Donald Bolinger – absent.
