The Township would be responsible for adopting an ordinance, purchase and maintenance of signs. The Board discussed safety issues with prohibiting the brake retarders and decided against prohibiting their use.

Bryan Cummings announced a donation was received from the Civic League in the amount of \$2000 to be used for the concrete pad in front of the salt shed.

John Martin submitted a letter letting the Board know he is interested in possibly purchasing a piece of property that contains a sewer easement to be used to connect VCC to the Borough's sewer system. He would like to use this easement to provide service to the piece of property he wishes to purchase. He would like the township's blessing, as well as information on potential steps to move forward and a cost estimate.
