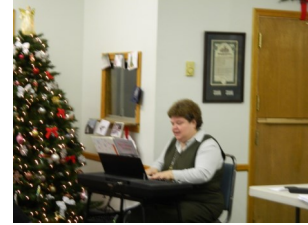

## Equipment Purchases

This year, the township was able to purchase equipment such as a grader, belt loader, and broom attachment for the tractor. This equipment will enable the workers to berm and ditch along township roads as well as grade gravel roads. This work had already begun and will continue into 2014.



## Low Income Heating Assistance Program Now Open

Pennsylvania's Low Income Home Energy Assistance (LIHEAP) grant program is now accepting applications. LIHEAP provides grants of up to \$1,000 to help low-income families pay heating bills during the winter months. LIHEAP also offers crisis grants of up to \$500 for families that experience heating emergencies, such as a broken furnace, fuel shortage or utility termination.

The program is targeted to individuals and families earning less than 150 percent of the federal poverty level, or about \$17,235 for a single individual or \$35,325 for a family of four. Grant amounts are based on income, family size, type of heating fuel and region.

Local residents can also apply for LIHEAP grants online at the Commonwealth of Pennsylvania Access to Social Services (COMPASS) website, [www.compass.state.pa.us](http://www.compass.state.pa.us). More information on the program is also available by calling the LIHEAP hotline at 1 (866) 857-7095.

## Dog Licenses

2014 Dog Licenses are now available at the township building. All dogs 3 months or older are required by law to be licensed. If you are a senior citizen, age 65 or older, or a disabled resident, a discount is available. Dogs that are spayed or neutered also receive a discount.

## What's in the Budget?

The 2014 Budget had been approved at the December Board of Supervisors meeting. The 2014 budget will include replacing another culvert on Means Road and the purchase of a tractor/mower or other equipment out of the General Fund. Also out of the General Fund is a plan to install an I-beam in the pavilion attached to the garage in order to make this area more accessible to store equipment. Seal coating on Angel Road, Vance Road, Lusk Road, Rodgers Road, and a portion of Indian Run Road, as well as grinding, grading, and rolling Brenneman Road are to be considered for 2014 out of the State Liquid Fuels Fund.

## Electronics Recycling Guide

**Best Buy:** Retail stores will take three items per day per customer. Accepts nearly anything electronic (no matter where purchased) including TVs, computers, cell phones, DVD players, sweepers, and more. Note: Some stores do not accept larger electronics.

**Goodwill:** Accepts any brand of used computer equipment in any condition with accessories. Printers, scanners, and fax machines are also accepted.

**Staples:** Accepts computers, laptops, printers, copiers, scanners, shredders, cameras, and phones any brand, any condition, even if purchased elsewhere. Also accepts batteries and printer cartridges.

**Lark Enterprises:** Accepts laptop computers, I-pods, cell phones, and printer cartridges.

## Landlord Rental Notices

On June 12, 2013 the Wilmington Township Mercer County Board of Supervisors enacted Ordinance 2013-2, The Tenant Registration Ordinance. The Supervisors found this necessary due to the new Earned Income Tax reform (local taxes), collection of per capita tax, and for the health and safety of all individuals that reside within the township. This will not only ensure proper collections and disbursement of the per capita taxes and EIT, which is withheld by the employer and eventually paid to the Township, but also helps identify the residents within our Township if and when an emergency should occur.

In summary, the Ordinance sets forth the Landlords responsibility to submit a form provided by the township, including each tenant's name and address. This must be completed and returned to the Township by January 30, 2014 and again within 30 days after a change in occupancy. If not done, a fine of \$25.00 per day could be enacted if a violation occurs. A copy of the complete Ordinance is on file at the Township Office for your review.

This is not meant to be a violation of your privacy. In this rising economy, it is intended to first and foremost aid us in keeping your local tax rate from increasing, by reassuring the EIT tax is correctly distributed to us, and second to help identify who is living within the Township.

If you are a landlord, you should have received a letter and form to return to the township building by January 30, 2014; if you did not receive one and need one, please contact the township office as soon as possible.

## Property Tax/Rent Rebate Program

The Property Tax/Rent Rebate Program benefits eligible Pennsylvanians age 65 and older; widows and widowers age 50 and older; and people with disabilities age 18 and older. The income limit is \$35,000 per year for homeowners, \$15,000 annually for renters and half of Social Security income is excluded.

Property Tax/Rent Rebate application forms and assistance are available at NO COST from Department of Revenue district offices, local Area Agencies on Aging, senior centers and state legislators' offices.

The department is aware that a company is contacting older Pennsylvanians by mail, offering to prepare Property Tax/Rent Rebate applications for a fee. While it is unfortunate that a company is charging for a service that the government and other agencies provide for free, there appears to be nothing illegal about the offer.

## Care of Onlot Septic Systems

Proper septic system care and maintenance is vital to protecting public health, preserving valuable water resources, and preventing unnecessary and expensive repairs to onlot sewage systems.

Failure to properly maintain your onlot septic system can lead to system back-ups and overflows, which can result in costly repairs, polluted local waterways, and risks to public health and the environment

Homeowners with onlot sewage systems should do the following:

- Do pump your septic tank as needed.
- Don't pour fats, grease, and solids down drains or toilets, which can clog your system's pipes and drainfield.
- Don't allow family members or visiting guests to put coffee grounds, dental floss, disposable diapers, flushable wipes, feminine hygiene products, cigarette butts, or cat litter down sinks or toilets.
- Do repair faucet leaks, and install faucet aerators and other water conservation measures, and spread out laundry and dishwasher loads throughout the day. Too much water at once can push solids out of the septic tank if it hasn't been pumped recently, which can clog the drainfield, requiring an expensive repair.
- Don't park on or drive over your drainfield and any other buried pipes to your onlot sewage system.

Dogs 3 months and older are required to be licensed. Licenses are issued on the calendar year. Mercer County residents can obtain a license at the township office.



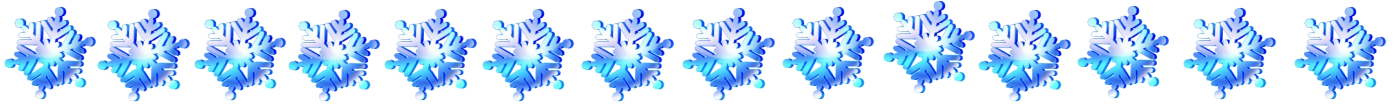
