

ORDINANCE NO. 2012-1
WILMINGTON TOWNSHIP, MERCER COUNTY, PENNSYLVANIA

AN ORDINANCE TO AMEND ORDINANCE NO. 1998-5 CHANGING THE DISTANCE FROM 250 FEET TO 150 FEET AS THE REQUIRED DISTANCE FROM THE SANITARY SEWER MAIN LINE OR EXTENSIONS THEREOF TO CONNECT TO SAID SYSTEM.

BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF WILMINGTON TOWNSHIP, MERCER COUNTY, PENNSYLVANIA, PURSUANT TO THE AUTHORITY OF THE SECOND CLASS TOWNSHIP CODE AND ANY OTHER APPLICABLE LAWS OF PENNSYLVANIA, AND IT IS HEREBY ENACTED AND ORDAINED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

SECTION 1: PURPOSE.

Ordinance No. 1998-5 is amended for the purpose of bringing that Ordinance into conformity with existing law regarding the distance between structures and the sewer line and requiring connection thereto.

SECTION 2: REQUIREMENTS.

The requirement in said Ordinance 1998-5 at Section 1(a) and Section 2 setting a 250 foot limit requiring connection to the sanitary sewer main or main line extension is hereby amended to read 150 feet to be consistent with Pennsylvania Statutory Law. Therefore, all references to 250 feet in said Ordinance are changed to 150 feet which shall hereafter be the footage requirement for connecting with the main sanitary sewer line or main line extension.

SECTION 3: REPEAL.

All Ordinance and parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 4: SEVERABILITY:

Should any section or part or provision of this Ordinance be declared by an appropriate authority to be unlawful or unconstitutional, all others terms, conditions, provisions and parts hereof and of any code of which this Ordinance may or may be considered to be a part of shall continue in full force and effect as if the provision declared to be unlawful or unconstitutional had been omitted as of the date of final enactment hereof.

SECTION 5: EFFECTIVE DATE:

This Ordinance shall take effect thirty (30) days after the enactment thereof.
