

ORDINANCE NO. 2013- 3,
WILMINGTON TOWNSHIP, MERCER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE TOWNSHIP OF WILMINGTON, MERCER COUNTY, PENNSYLVANIA, TO AMEND ORDINANCE NO. 2010-2, AS AMENDED, SETTING FORTH AMENDMENTS TO SECTION IX SYSTEM REHABILITATION.

BE IT ENACTED AND ORDAINED by the Board of Township Supervisors, Wilmington Township, Mercer County, Pennsylvania, pursuant to the authority of the Pennsylvania Second Class Township Code, Wilmington Township hereby enacts and ordains by authority of the same as follows:

SECTION 1: PURPOSE

Ordinance No. 2010-2, which is an Ordinance governing municipal management of on-lot subsurface sewage disposal facilities and as was amended at 2012-2, at Section VIII-Maintenance, is further amended by adding and clarifying provisions dealing with obligations regarding connection to a municipal sanitary sewer system and the maintenance of any said connection.

SECTION 2:

Section IX of Ordinance No. 2010-2 enacted November 10, 2010, is amended to provide as follows:

i. All persons as defined in the Ordinance whose dwelling house or business structure, is located within one hundred fifty (150) feet of any main sewer line shall be and is required to connect to that main line at their sole expense except as provided herein.

j. Connections to the main sewage line required in Section i shall be completed within one hundred twenty (120) days of the completion of any main line coming within the one hundred fifty (150) foot limit as set forth above.

k. In the event a grinder pump is needed and/or required by the Township, then the Township shall be responsible for the initial purchase of the grinder pump but thereafter the resident will be responsible for the installation, maintenance and subsequent replacement of the grinder pump through an approved contractor list provided by the Township. All residents requiring grinder pumps will have the same grinder pump as selected at the sole discretion of the Township. All initial grinder pumps will be installed by the same contractor or contractors selected by and approved by the Township.

SECTION 3: REPEAL

All Ordinances and parts of any Ordinances inconsistent herewith are repealed.

SECTION 4: SEVERABILITY

If any section or clause of this Ordinance shall be adjudged invalid, such adjudication shall not affect the validity of the remaining provisions which shall be deemed severable therefrom.

SECTION 5: EFFECTIVE DATE

This Ordinance shall take effect thirty (30) days after the enactment thereof.
